Violation 1 Item 1

WAC 296-54-529(6)

In the following instances the employer did not ensure that special precautions were taken when felling trees near power lines.

- 1) The employer did not notify the power company before felling any tree that would appear to hit the power line.
- 2) The employer did not notify the power company immediately when a felled tree made contact with a power line.
- 3) The employer did not keep employees clear of the area once a tree made contact with a power line until the power company ensured that there was no electrical hazard.

This exposed the employees to possible electrocution which could result in serious injuries or death.

The above violation contributed to an accident that resulted in the death of an employee on 10/15/2012

Violation 1 Item 2

WAC 296-54-539(4)

Violation Type: Serious

Violation Type: Serious

The employer did not ensure that the person who was placed in charge of tree thinning and felling operations acted in a competent manner. The supervisor who was placed in charge of ten employees at the Chimanoke Unit #6 timber sale did not identify hazards in the surrounding where employees were assigned to fall trees near electrical hazards. This exposed the employees to potential electrocution from trees hitting or becoming entangled into 115 KV power lines that were within falling distance of the trees being felled.

Violation 1 Item 3

Violation Type: Serious

WAC 296-54-53910(14)(b)

The employer did not ensure that the employee cutting timber left enough hinge wood to hold the tree to the stump during most of its fall so that the hinge is able to guide the tree's fall in the intended direction. Serious or fatal injuries likely if the tree does not fall in the intended direction.

This violation was corrected during the inspection.

Assessed penalty: \$4,500.00

Violation 1 Item 4

Violation Type: Serious

WAC 296-54-507(1)

The employer did not ensure that safety training was provided to each employee. During the inspection of the Washington State, Department of Natural Resources (DNR), Northeast region, Department of Correction offenders under the control of DNR did not receive adequate training. In that,"The Wildland Fire Chain Saws S-212" training course was not completed prior to allowing employees to operate chain saws and fell trees. The proficiency test and unit quizzes was not completed prior to the employees work assignments.

By not providing the entire training prior to allowing employees to operate chainsaws and fell trees, the employees were exposed to hazards likely to result in serious injury or death from unsafe cutting techniques and improper chainsaw operation.

This violation was corrected during the inspection.

Violation 2 Item 1

Violation Type: General

WAC 296-54-51510(3)

The employer did not ensure that safety meetings were documented with subjects discussed.

For Employers

If you are cited for a violation of Occupational Safety and/or Health rules, you have the right to appeal the citation. **You have 15 working days from the date you receive this citation to appeal.** (RCW 49.17.140(1)) "Working day" means a calendar day, except Saturdays, Sundays and all legal state holidays. Your appeal must be in writing. It may be mailed, faxed, or personally delivered.

For violations classified as serious, willful, repeat serious, or failure to abate serious, an employer must correct the violations by the date listed on the Citation and Notice / Employer's Certification of Abatement form unless a stay of abatement date is requested in the appeal as described on this page. A stay of abatement date means the employer's requirement to abate or correct the hazard is put on hold until the appeal is resolved. All general and repeat general violations under appeal automatically have stay of abatement dates until a final order on those violations has been issued. If you only need an extension of an abatement date, please see the above section entitled, "If you are unable to fix the hazard(s) by the correction due date(s)".

Your appeal must include:
