#### Concern:

Lacks judicial experience (had been offered the opportunity to serve as a judge pro-tem).

## **District Court Judge 8**

Richard M. Leland

- 1. Judge Leland came to the interview prepared with a resume which included his judicial philosophy on preserving the family, community and the courtroom.
- 2. Leland is the incumbent and has extensive private practice experience and experience in complex commercial lending.

- 3. Leland has been a loaned executive to the United Way, as well as a long time Sunday School teacher, a little league director, a coach for SYSA, YMCA, AAU (boys and girls" teams) and he is a Precinct Committee Officer.
- 4. Leland's answers to WBWV questions showed creativity and compassion. He demonstrated knowledge of issues and supported the Constitution while looking for local practical solutions with community sentencing and Mental Health Therapeutic Court.
- 5. His approach is to protect victims and reduce recidivism by using creative and prevention solutions
- 6. Candidate is driven, has integrity, and is a hard worker.

<u>Concern</u>:

Leland's creative sentencing and correction suggestions/solutions may take longer than he wants to implement.

#### Timothy D. Trageser

Positive statements:

- 1. Trageser has an extensive courtroom experience as a defense attorney.
- 2. He believes the court needs additional efficiency measures. He gained that opinion, in part when doing audits; he was able to look at functionality as well as dollars and "sense." He is capable of addressing process and efficiency issues.
- 3. Trageser emphasizes the importance of innovation balanced with "cost vs. benefit" for special courts including Mental Health Therapeutic Court and community sentencing.
- 4. He believes in allocating additional resources to MHTC.

Concerns:

- 1. He has the endorsement of the labor council and is pro-union.
- 2. Trageser feels becoming a judge is a natural progression for lawyers.
- 3. His experience with volunteerism in the community, religious or otherwise is limited.
- 4. He emphasizes case law greater than the Constitution because it is based on precedent.
